Goals/Objectives/Action Steps

Curriculum

Goal 1: To assure that all students master an appropriately prioritized and sequenced K-12 curriculum that develops enduring understanding, essential skills, and critical knowledge as defined through the policies of the West Virginia Board of Education and the West Virginia Content Standards and Objectives.

Objective 1.1 Increase the number of students tested on WESTEST 2 that meet mastery and beyond in math and reading language arts.

Action Step Goal: 1 Action Step 1.1 Identify strengths and weaknesses using WESTEST 2 item analysis data and formulate a priority list to address student deficiencies.

Action Step Goal 1: Action Step 1.2 Schedule days for teachers to analyze data at school level.

Action Step Goal 1: Action Step 1.3 Provide professional training and staff development days to maintain standard based model (Investigations) for mathematics by scheduling on-site training.

Action Step Goal 1: Action Step 1.4 Continue to develop and conduct formal/informal benchmark testing for both math and RLA for the new 21st Century CSOs.

School Effectiveness

Action Step Goal 3: Action Step 3.3 Continue attendance at WVDE sponsored 21st Century Strategic Plan Meetings.

Action Step Goal 3: Action Step 3.4 Continue book studies related to implementation of Five Year Strategic Plan.

Action Step Goal 3: Action Step 3.5 Schedule monthly Administrative Cabinet meetings discussing issues and goal attainment related to Five Year Strategic Plan.

Action Step Goal 3: Action Step 3.6 Continue Super Faculty Senate Meetings with School Faculty Senate Presidents.

Action Step Goal 3: Action Step 3.7 School curriculum team presentations to County Board of Education.

Action Step Goal 3: Action Step 3.8 Staff will attend teacher recruitment fairs.

Actions Step Goal 3: Action Step 3.9 Establish early timelines for job postings. Fill positions in an expedited manner in an effort to recruit highly qualified candidates.

Student/Parent Support

Goal 4: To assure that all students receive the support they need to achieve mastery and beyond of the essential curriculum and that all parents are treated as valued partners in their child's educational process.

Objective 4.1 Increase percentage of parent involvement (PTSO, parent/teacher conferences, workshops, awards assemblies, open houses and IEP meetings).

Objective 4.2 Youth in Pendleton County will be supported in achieving healthy lifestyles which will promote student success.

Action Step Goal 4: Action Step 4.1 Continue to administer and analyze a parent survey to determine preferences and challenges related to involvement with schools.

Action Step Goal 4: Action Step 4.2 Identify strategies for responding needs identified on the parent survey.

Action Step Goal 4: Action Step 4.3 School to assemble volunteer logs, invite parents to awards assemblies, workshops, open houses, etc. by a variety of communication tools.

Action Step Goal 4: Action Step 4.4 Continue to provide workshops and resources through the Parent Education Resource Center and Title I Program.

Action Step Goal 4: Action Step 4.5 Develop technologies through websites for more regular communication with parents, such as e-mail addresses for all staff and provide homework assignments through website.

Action Step Goal 4: Action Step 4.6 Develop strategies to involve community in our schools beyond just school business partnerships.

Action Step Goal 4: Action Step 4.7 Establish a youth council to develop a process for making decisions related to increasing the assets for the youth in our community.
